DURING THESE PROGRAMS, 187 VOLUNTEER GUIDES ESCORTED 378 VOLUNTEER MUSICIANS AS THEY PLAYED DIRECTLY AT THE BEDSIDES OF PATIENTS. IN TOTAL, THE ORGANIZATION DELIVERED THE HEALING POWER OF MUSIC TO NEARLY 57,000 INDIVIDUALS IN THIS PAST YEAR.
